Current Vacancies – The WSEHA membership was reminded of current vacancies that exist within the WSEHA Board (most notably for a Northwest Region Vice-President), and the ongoing need for members to serve on the various Committees, including serving as Chairpersons.

New Business

- **2016 Annual Education Conference** The Board informed the membership of its intent to conduct a 2016 WSEHA AEC, and that they were looking to possibly hold the AEC in the Vancouver/Portland area. We will contact the Oregon Environmental Health Association to see If they would be interested in conducting the AEC jointly. WSEHA will also work with the local (Clark County) health district in planning the AEC. As it is late in the spring conference cycle, we are currently looking at holding the Conference in late May, just before the Memorial Day weekend.
- **Upcoming National Environmental Health Association Conferences** Ned Therien reminded the attendees that NEHA will be holding its 2016 Annual Education Conference, June 13-16, in San Antonio, Texas. The 2017 AEC is planned for Grand Rapids, Michigan.
